### **Job Description Summaries**

Following is a summary of the responsibilities involved in each of the three positions I currently hold. Would greatly appreciate at least two of these being taken off my plate.

How the tasks to carry out the responsibilities are performed is up to the individual. I know that I've modified things over the years, and I'm happy to share the "how" I do things – but it doesn't mean that it must continue that way. New perspectives and ways of doing things are welcome.

Want to know more before making a decision? Let's talk.

#### **Specialties Coordinator:**

Offer items for sale that promote a sense of club membership and belonging to a group (e.g., t-shirts, caps, jackets).

Offer items for sale obtained from AVA (e.g., IVV books, New Walker packets, book covers, state bars, *Starting Point* book).

Manage/track inventory. Identify new items. Secure cost estimates. Present to Board for approval. Ensure specialty inventory is brought to each Walk 'n Mass traditional/day event. Check with POC of traditional event for staffing of Specialties table. After event, remit proceeds to club treasurer.

NOTE: There is discussion of eliminating the apparel inventory and keeping only the AVA-related items. If that happens, will be a lot less inventory to manage.

#### **Volunteer Staffing Coordinator:**

Contact club members by email or telephone to fill stations needed to facilitate delivery of excellent customer service and smooth operations at a traditional event.

Communicate with the event POC to determine staffing timeframes for a specific event. Obtain mailing list sorted by city from membership

chairperson. Contact members who live in towns/cities located near the location of the event to fill the various stations.

#### Walk Coordinator:

Encourage and guide club members in planning safe, non-competitive walking and biking events in interesting areas for the enjoyment of other volkssporters and the general public.

Submit documentation and reports to AVA within established deadlines using the online process (i.e., access the club account using my.ava.org) for event sanctioning and participation reports for traditional, year-round, and seasonal events.

Update event data on the my.ava.org website as needed to ensure current information is displayed.

Communicate as needed with year-round, seasonal, and traditional event POCs regarding event planning, operations, and reports. Request and obtain data using existing forms and checklists. Coordinate design and production of event award, if any.

Attend monthly club meetings and collaborate with other volunteer leadership to orchestrate well-prepared, safe, fun, and well-executed events.

Write monthly article for newsletter to keep membership informed of event happenings.

Some of the tasks involved in this role can be delegated to others. For example, using the club account on my.ava.org to enter and update event information, renew year-round and seasonal events, and post files that use OSB registration can easily be performed by someone else—as long as the Walk

Coordinator relays the information to that person.



### Hopkinton: It All Starts Here

For anyone who has watched the Boston Marathon, you should be familiar with the sign at the starting line in Hopkinton – "It All Starts Here." Since this year is the 128th running of the Boston Marathon and 2024 marks the 100th year that Hopkinton has served as the starting line, then it didn't always start in Hopkinton. The original start line for the Boston Marathon was Ashland; however, that is a story for another time.

This year Walk 'n Mass can also claim that "It All Starts Here" in Hopkinton since our official walking season started with our annual soup walk which this year was held in Hopkinton. We had originally planned this walk for 2020; however, COVID derailed that plan and it took another four years before we were able to have Hopkinton serve as our start point. This walk was also a memorial walk in honor of Barbara Kimball, a long-time Walk 'n Mass member who passed away in April of 2022. We were very happy that Barbara Kimball's family was able to participate in the walk and to join us at the soup social.

When I started my day at 7:00 in the morning, there were light snow flurries that then turned into light rain. Thankfully, there were no downpours during the day and the weather was not too cold for walkers (although, it was a bit chilly for our volunteers whose duties kept them outside – I'll bet that they were especially thankful for the hot soups that were available when their shifts ended!). Participants had a choice to do a 5km route, a 6km route, or they could do both routes in order to complete an 11km walk. Both routes started at St. Paul's Episcopal Church on Wood Street. The 5km route headed through downtown Hopkinton and then to the Town Common which contains many Boston Marathon memorials, as well as a Doughboy statue and a new World War II Honor Roll memorial. Since Hopkinton was celebrating their 100 years of hosting the Boston Marathon, some 100th anniversary items were displayed at the Town Com-

mon. After leaving the Common, walkers continued through residential areas and passed Barbara Kimball's former home before returning to the start line. The 6km route took walkers on the Center Trail (a multi-use trail, which generally follows a railroad line to Milford that was built in 1863 and removed in 1950). Upon leaving the rail trail, walkers continued past the school complex and fields which serve as the athlete's village for Boston Marathon runners. After stopping at the checkpoint at the Hopkinton Center for the Arts, the route continued through residential areas and then returned to the start point for the soup social.

I would like to thank my co-POC Bea Hait for all her assistance on this event. Her expertise in running walking events is so valuable and extremely appreciated! ### Walk Coordinator Speaks

Warren, RI – DATE CHANGE — Unexpectedly, our start point notified us in mid-April that they could no longer accommodate our May 18 date. So, the new date for this walk is Saturday, June 29, 2024.

Fall River, MA Seasonal Event — It turns out that policies at the state-run Visitor Center at Heritage State Park prevent them from hosting our Walk Box without us applying for (\$45) and receiving approval for a Special Use Permit. The new start point is Work Out World (WOW!) at 18 Pocasset Street and the Walk Box is already in place [see page 3 for more].

Participation Fee — A reminder that a participation fee is now required of all walk/bike participants. At a traditional event – one that is scheduled for a specific day and is staffed by club members – the participation fee is \$4. Of this fee, \$2 is paid to AVA and \$2 remains with the club.

As a benefit of membership in WnM, when you participate in one of our club-sponsored seasonal or year-round events, you are granted a \$1 discount when registering in person. Please mark the appropriate participation category on the Registration Log in the Walk Box. Of this \$3 fee, \$2 is paid to AVA and \$1 remains with the club. Unfortunately, this option is not accommodated when using the Online Start Box (OSB), but you can take advantage of this discount when attending

on a Group Walk date where in-person registration is available – even for Boston (Back Bay and Freedom Trail), Cheshire, Oak Bluffs, and Provincetown, which currently do not have physical Walk Boxes.

Upcoming WnM 2024 walks — Disappointingly, no locations or dates have been suggested for traditional day events in the coming months. We will therefore schedule more frequent dates for Group Walks of our seasonal and year-round locations as incentive for our club members to get together and walk — if only to see one another when we register to walk at the designated time.

You may, of course, choose to follow the written route directions and walk on your own or walk with the group. Often, several people choosing to walk with the group will also opt to stop together for lunch – either while on the walk route or after finishing. Another opportunity to chat with and get to know your fellow club members and to put our motto into practice: Fun – Fitness – Fellowship – and Food!

Group walk dates are publicized through the newsletter, email notifications, Facebook, Meetup, the Northeast Region calendar page, and our club website. Please check walknmass.org for up-to-date status of Group Walks. Often, if severe rainfall is predicted, the group walk will be rescheduled.
