Trail Master's Diary: Warren

There are many ways to enjoy beautiful summer days in New England. Some people like to head to the beach or to the park. Maybe take a walk through a seaside town. Walk 'n Mass invites you to join them on June 29 to explore the pretty town of Warren, Rhode Island with 5km and 10km routes. Warren was originally part of the Massachusetts Bay Colony until it was ceded to Rhode Island in 1747. It was the original home of Brown University and was well known as a whaling and ship building center in the mid-18th century. By the mid-19th century, whaling had declined and Warren turned to textile manufacturing. Today it still has several thriving waterfront businesses.

The first 5km loop heads down Water Street through the Warren Waterfront Historic District featuring homes and businesses built in 19th century revival and Victorian architectural styles. It has been the center of Warren since the mid-18th century and is listed on the National Register of Historic Places. Note the historic plaques featured on many buildings along the way. Walkers will pass by Maxwell House, the oldest brick house in Warren, built between 1752 and 1756, along with many shops and restaurants. Be sure to look down the side streets for a glimpse of more historic homes.

The route then heads to Warren Town Beach along the Warren River before heading to Main Street and downtown Warren. Across the street is the George Hail Free Library, built in 1888 in the Romanesque revival style, and the Warren Town Hall, built in 1900 in the Renaissance revival style. Walkers will pass by the Warren Armory, a Gothic revival building given to the town of Warren in 1842 from the state of Rhode Island for its support during the Dorr Rebellion. The route continues through the Warren Town Common past the Wall of Honor listing the names of Warren residents who died defending their country through the various wars. It passes the First Methodist

Church, the first in Rhode Island and the second in New England before heading back to Main Street passing various shops and restaurants. Walkers will continue past the East Bay Government Center before heading to the East Bay Bike Path and the finish for 5km walkers and checkpoint for the 10km route.

The second 5km loop is comprised of a portion of on the East Bay Bike Path, a 14.5-mile route between Bristol and Providence. Many of us are familiar with the southern terminus of the path since it is along the Walk 'n Mass Bristol SE. Walkers will head into Barrington over the Palmer River, then cross another bridge over the Barrington River to Police Cove Park. Note the "sunbathers" in the park. The path continues to downtown Barrington, crossing County Road and passing the Barrington Shopping Plaza. The turnaround point is near the Bayside Y along the path as

walkers head back to the finish.

Both loops are on paved, mostly flat surfaces and have an AVA rating of 1A. They are doable for strollers, but some uneven sidewalk spots could make it difficult for wheelchairs. Join Walk 'n Mass for a 5km or 10km summer walk in the seaside town of Warren, RI on June 29. Hope to see you on the trail!

TRAIL DESCRIPTIONS: The walk route traverses Battleship Cove, home to the world's largest collection of World War II naval ships, including the Battleship USS Massachusetts, affectionately known as "Big Mamie" (fee to District, an ethnic Portuguese neighborhood with cobbled streets and sidewalks, filled with enticing smells from the numerous bakeries & restaurants. Next, the walk route visits Kennedy Park, the first of two Frederick Law Olmsted designed parks on the route. Enjoy spectacular water a large Gothic building constructed by Canadian immigrants, and Lizzie remain one of America's great unsolved crimes. The route also explores the second Olmsted designed park, North Park; enters several historic neighborhoods; visits Veterans Memorial Bicentennial Park with impressive Veterans Memorial Wall; and returns via a boardwalk which hugs the tour museum). The route then proceeds to the Columbia Street Cultural views before continuing to the downtown area passing Saint Anne's Church, Borden's house. The infamous Borden axe murders that took place in 1892 tributes including an Iwo Jima sculpture & 80% replica of the Vietnam Taunton River to Heritage State Park.

parking lot to Captain Thomas J. Hudner, Jr. Memorial Building and enter Note: 5km route returns to the finish after visiting the downtown area. Restrooms: From Battleship Cove, cross wooden pedestrian bridge from through main entrance or bear left to reach outside restroom door. RATING: On paved surfaces & pathways with some hills, these walk routes have an AVA trail rating of 1B, difficult for strollers but not suitable for wheelchairs.

AWARD: This is an IVV Credit Only event; no award.

AVA SPECIAL PROGRAMS: Lighthouses, Par for the Course, Step to the Beat, Town Halls/City Halls, and Walking with America's Veterans

DIRECTIONS:

From the North:

- Take either I-495 South or Route 128/I-95 South to Route 24 South.
- 24 South to Exit 7 (Route 79 South). Follow the Battleship Cove signs.
- 79 South to third exit (Route 6 East/New Bedford)
- Straight on Davol Street to right on Central Street passing Battleship Cove to first left on Anawan Street.
- Straight through traffic light. Parking lot is on the right. v.


From Cape Cod:

- I-195 West into Fall River to Exit 11 before the Braga Bridge, and bear RIGHT.
- Merge onto Central Street, stay in middle lane to go straight. 2
- Pass Battleship Cove to first left at Anawan Street.
- Straight through traffic light. Parking lot is on the right.

From the West:

- I-195 East into Fall River. Take Exit 11 (Routes 79/138).
- Stay in RIGHT lane to continue on Route 79 North, merging onto Davol
- RIGHT at first traffic light onto Pocasset Street. Parking lot is on right.

proceed down two flights of stairs (WOW! is on ground floor). Ask for Walk From parking lot, enter WOW! building under the black canopy and Box at the front desk.
